Record of Discussions of the meeting held by Principal Secretary to PM to review the preparation of guidelines for Pradhan Mantri Krishi Sinchai Yojana (PMKSY) on 14.11.2014 in PMO, South Block, New Delhi

2. Secretary, Water Resources, River Development & Ganga Rejuvenation made a detailed presentation on the proposed scheme of Pradhan Mantri Krishi Sinchai Yojana (PMKSY).
3. Secretaries of Department of Agriculture and Cooperation, Rural Development, Water Resources, River Development & Ganga Rejuvenation and Additional Secretary, Department of Land Resource gave a detailed status of the existing scheme which are related to irrigation in the respective Ministries / Departments.
4. After a detailed discussion, the following decisions were taken:
  - (i) For the purpose of the implementation of the PMKSY, D/o Agriculture and Cooperation could be the nodal Department.
  - (ii) The design of the Scheme should be such that to achieve the basic objective of the "Her khet ko pani" and "Per drop more crop".
  - (iii) Measurable parameters of the Scheme may *inter-alia* include gross irrigated area, agricultural production, agriculture productivity, abridging the gap between irrigation potential created and irrigation potential utilized etc.
  - (iv) Programme design should provide flexibility at state level in planning, approval and execution of the scheme with respect to stated objectives.
  - (v) While the approval could be given at state-level, participation of Central Government Ministries / Departments through their representatives in approval process may be considered.
  - (vi) A comprehensive irrigation plan should be prepared at district-level duly factoring in the watershed / command area approach keeping in view the existing potential of surface and ground water availability.
  - (vii) Secretary, Department of Agriculture and Cooperation, in consultation with the other Ministries / Department will prepare a Concept Paper in this regard by 15th December 2014, with detailed guidelines for the implementation of the scheme.
5. The meeting ended with a vote of thanks to the Chair.
